Reg. § 1.147(f)-1, for a plan of finance for the following purposes: (a) constructing, improving and equipping of an educational facility located at 12415 North Grant Street, Thornton, Colorado, in Adams County including adding new gym space, classrooms and related improvements and a new loop road and parking (the "Facility"); (b) funding a bond reserve fund for the Bonds; (c) funding capitalized interest on the Bonds; and (d) paying certain costs of issuance of the Bonds (collectively, the "Project").

The proceeds of the Bonds will be loaned by the Authority to Global Village Academy - Northglenn Building Corporation, a Colorado nonprofit corporation (the "Corporation"). The educational facilities to be financed with the proceeds of the Bonds are located at 12415 North Grant Street, Thornton, Colorado, in Adams County.

The Bonds will constitute special limited obligations of the Authority payable solely from revenues derived by the Authority pursuant to a Loan and Security Agreement, by and between the Authority and the Corporation. The Corporation will remain the nominal owner and Global Village Academy - Northglenn, a Colorado nonprofit corporation and an organization described under Section 501(c)(3) of the Code will be the principal user of the Facility and related bond financed property. All or a portion of the Bonds are expected to be issued as qualified 501(c)(3) bonds pursuant to the Code.

The Bonds and the interest thereon shall never constitute the debt or indebtedness of the Authority, the State of Colorado or any political subdivision thereof. The Authority has no taxing power.
